ACCOMMODATION REQUEST FORM

Instructions

1. Use as much space as necessary within each response area to provide full information.
2. Complete Part A.
3. Save the document in PDF format with the name "Accommodation Request—Last Name." Save it to a private area on a file library, such as to your personal computer.
4. Submit the form as an attachment to people@peacethroughaction.org.
5. Peace Through Action USA will review your request and begin an interactive process to develop a reasonable accommodation plan. We will write our proposed plan in Part B. We will return the form to you to either accept or reject the first plan. If accepted, both parties will sign the plan in Part C. If rejected, both parties will return to the interactive process to develop an alternative plan in Part D and accept or reject it in Part E.
