Peace Promotion -- Peace Through Action USA supported individuals in creating peace in their communities by pointing them to practical solutions they can take within their families, neighborhoods, and networks to decrease aggression and violence and increase care and compassion. We suggested peaceful practices to individuals through a regular electronic newsletter that reached over 500 people; by posting information sheets to our website, which reaches the public at large; and by offering virtual learning events available to the public large.

Peace Agents -- Peace Through Action USA initiated its Peace Agents program, which supplies compensated servant leaders (peace agents) to U.S. communities seeking greater interpersonal peace. We serve as an intermediary--recruiting, screening, and matching people who wish to focus on peacebuilding to organizations that seek to increase peace between people and groups in their communities. Peace Through Action USA raises funds for and supervises our peace agents to lower barriers to human resources that community organizations face. Our peace agents lead community peace projects. In 2021 we began to demonstrate the peace agent program with a community peace project in Calvert County, Maryland.

If a director believes the return to have an error, that concern is brought to the attention of the treasurer. The treasurer and chief executive officer then assess the concern. If is concern is found warranted, the chief executive officer would prepare an amended return with the corrections made.

Form 990, Part VI, Section B, Line 12c - Peace Through Action USA educates its directors on the conflict of interest policy. We require directors to report known conflicts of interest annually during their completion of an information collection form. Thereafter, the chair is alert for potential or actual conflicts of interest that arise in the course of board of directors business. Also, any director can raise a conflict of interest concern. The board of directors will then take appropriate actions to prevent or resolve the conflict of interest following the provisions of the organization's conflict of interest policy.

Form 990, Part VI, Section B, Line 15 - Peace Through Action USA has a policy on executive compensation. The board of directors followed the policy for establishing a pay range for the chief executive officer position by appointing a compensation committee comprised of a subset of directors. The committee completed its process in 2017, in anticipation of the organization hiring a chief executive officer. Peace Through Action USA began paying its chief executive officer in 2021. (In prior years, the chief executive officer was a volunteer.) The chief executive officer's compensation falls below the accepted compensation range determined by the compensation committee.
