Peace Explorers -- Peace Through Action USA supported individuals in increasing peace by pointing them to practical solutions they can take within their relationships and communities to decrease social distress and increase compassion, constructive communication, and constructive conflict resolution. We suggested peace practices to individuals through a regular electronic newsletter that reached over 1900 people; by posting messages and calls for practical action on our social media channels reaching the public at large; by posting subject-specific information pages to our website, which reaches the public at large; and by offering virtual learning events available to the public at large.

Peace Agents -- Peace Through Action USA continued its peace agents program, which provides servant leaders to geographic communities to bolster their capacity to deliver peacebuilding activities. Peace agents lead community peace projects, which are collective impact alliances through which community members, guided by a Peace Through Action peace agent, select, organize, and deliver peacebuilding activities in their geographic areas. In 2025, we continued to demonstrate our community peace projects concept with a project in Calvert County, Maryland.

Peace Accelerators -- We commenced our Peace Accelerators program, which strengthens people's ability to increase peace in their relationships and communities by building peace skills together, making action plans for change, and discovering resources that support social well-being. This program includes three activities: Essential Peace Skills Trainings-intensive learning experiences focused on core communication and conflict resolution skills that people can apply across many social contexts. Participants learn, practice, and reflect through realistic scenarios; Practical Peace Solutions Sessions-brief workshops that demonstrate how constructive communication and conflict resolution skills work in real-life situations. Participants learn core techniques and practice them through structured role-plays and scenarios; and Peace Through Action Meet-Ups-small-group gatherings that guide participants through action planning and discovery of social well-being resources. Participants leave with concrete steps to increase peace in their relationships and communities.

The program has three activities. Essential Peace Skills Trainings are intensive learning experiences focused on core communication and conflict resolution skills that people can apply across many social contexts. Participants learn, practice, and reflect through realistic scenarios. Practical Peace Solutions Sessions are brief workshops that demonstrate how constructive communication and conflict resolution skills work in real-life situations. Participants learn core techniques and practice them through structured role-plays and scenarios. Peace Through Action Meet-Ups are small-group gatherings that guide participants through action planning and discovery of social well-being resources. Participants leave with concrete steps to increase peace in their relationships and communities.

Directors offer to recuse themselves, or the chair can require directors to recuse themselves.
